3. The certificate would be deemed to be invalid for other than the purpose for which it is given.
4. All the treatment operations should be performed by a qualified operator of the firm and necessary treatment records/data log sheets are maintained for necessary verification.
5. All the treatments should be performed as per the standards laid under ISPM-15 and the treated packing material should be marked with assigned code number prior to export as per ISPM-15.
6. The certified facility should abide by the instructions and guidelines issued by the Plant Protection Adviser from time to time.
7. The certified facility should submit a compliance agreement to the Plant Protection Adviser at the time of issuance of the certificate duly signed by the authorized signatory of the firm.
8. The certificate would be initially for two years from the date of issue and subsequently for two years from the date of renewal unless otherwise revalidated. The firm should apply for revalidation at least 45 days before expiry of certificate.
9. No liability would lie with the officers Dte. Of PPQS towards issuance of the certificate.
